A tax rate of \$.24672 per \$100 valuation has been proposed by the governing body of Frio Hospital District.

The no-new-revenue tax rate is the tax rate for the 2020 tax year that will raise the same amount of property tax revenue for Frio Hospital District from the same properties in both the 2019 tax year and the 2020 tax year.

The voter-approval rate is the highest tax rate that Frio Hospital District may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is not greater than the no-new-revenue tax rate. This means that Frio Hospital District is not proposing to increase property taxes for the 2020 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON MONDAY, SEPTEMBER 17TH, 2020 AT FRIO REGIONAL HOSPITAL AT 200 IH 35 S, PEARSALL, TEXAS, 78061.

The proposed tax rate is also not greater than the voter-approval tax rate. As a result, Frio Hospital District is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Frio Hospital District Board of Directors at their offices or by attending the public meeting mentioned above.

Indigent Health Care Compensation Expenditures

The Frio Hospital District spent \$4,181,881.54 from July 1, 2019 from June 30, 2020 on indigent health care compensation procedures at the increased minimum eligibility standards, less the amount of state assistance. For the current year, the amount increase above last year's enhanced indigent health care expenditures is \$543,537.70 this increased the voter-approval tax rate by \$.02440.
